CHARLES J. BONAPARTE CEREMONY

Today, we are celebrating the Twenty-fifth Annual Charles J. Bonaparte Day, in honor of the Forty-sixth Attorney General of the United States and the founder of the Federal Bureau of Investigation.

The Honorable Charles J. Bonaparte was appointed Attorney General in 1908, during the administration of President Theodore Roosevelt. However, Bonaparte soon discovered that he was hampered in carrying out President Roosevelt's "trust-busting" policies by the lack of a permanent investigative staff. Until then, the Justice Department had been restricted to hiring temporary investigators, usually borrowing them from the Treasury Department's Secret Service.

Despite Congressional prohibition, Bonaparte hired as permanent employees, nine of the Secret Service agents who had worked for the Department in formerly temporary assignments.

On July 28, 1908, acting on Presidential instructions, Bonaparte issued the order which made this force a permanent subdivision of the Department of Justice. In 1935, what had begun as a 23-man unit under Bonaparte was renamed the Federal Bureau of Investigation.

In addition to his service in the Roosevelt Administration, Bonaparte is remembered for his important work as founder of the National Civil Service Reform League and as an organizer and president of the National Municipal League.

In his honor, the monument at the Nineth Street and Pennsylvania Avenue entrance to the Main Justice Building was dedicated on June 22, 1961; a second tribute was paid on June 9, 1977, when the main auditorium in the J. Edgar Hoover Building was dedicated to the memory of Charles J. Bonaparte; and of course we honor his memory every year with this annual Charles J. Bonaparte Day Ceremony held in June, the month of his birth.

This year, in keeping with the ideals established by Charles J. Bonaparte, the Italian Historical Society of America is especially honored to bestow its highest award, the Bonaparte Citation, for Outstanding Public Service, to former Attorney General William French Smith. Additionally, special recognition as Charter Members of the Italian Historical Society of America's Hall of Fame will be bestowed upon three outstanding Italian-American employees of the Department: Mr. Americo R. Cinquegrana, Deputy Counsel, Office of Intelligence Policy and Review; Mr. Victor W. Caputy, Chief of Training, United States Attorneys Office, Washington, D.C.; and Mr. Jules J. Bonavolonta, Special Agent, Federal Bureau of Investigation.
